ANMF Vice-President's Corner-ANMF in action -2023 NorthWestern Nepal Earthquake



A 6.4 Magnitude earthquake hit Jajarkot, Rukum West, and surrounding areas of Nepal on 11/3/2023. More than 150 lives were lost and more than 350 injured, 40,000 plus houses were fully or partially damaged. More than 140,000 people were affected. While the Nepal Government coordinated the rescue works, ANMF USA, in coordination with ANMF Nepal, joined the relief works early on and actively coordinated with local partners in providing relief works in earthquake-affected areas.

ANMF USA initiated the fundraising via our Facebook page and our website. As of early December 2023, almost \$29,000.00 has been raised via various platforms. ANMF Nepal did the ground assessment with the help of the Karnali Academy of Health Science (KAHS), the Center for Mental Health and Counseling (CMS), and other partners. We had a Zoom round table discussion with the ANMF Nepal team, HAPSA, HFN, KAHS, ASK foundation, and others to assess the need in the affected areas so that we could plan better for relief and rebuilding works.



So far, we have distributed 1000 sanitation Kits, 500 postpartum packages (mother and infants), and 100 blankets. There were challenges encountered in distributing these items initially. Among those challenges were the government's one-door policy,

lack of proper coordination and protocol, poor accessibility in remote places, as well as lack of a centralized database.

The sanitation packets were of two types: one type consisted of toothbrushes, toothpaste, bathing and washing soaps, chlorine drops, nail cutters, and towels, and the second type consisted of sanitary napkins. Postpartum kits included Jeevan Jal, soap, peanut, pad, water guard, chana, soybean, and sarbottam pitho. ANMF Nepal worked with the public health department and the Center for Mental Health and Counseling to distribute these items in the affected areas. Various needs have been identified for temporary and long-term relief works.

About 60,000 temporary shelters will be needed to provide temporary housing. Winter has started, and cold-related illnesses will increase in those areas. Lack of proper sanitation related to infectious disease epidemics is another concern. Psychosocial counseling of the affected ones, training of existing or new health workforce to provide the current and future needs in the affected areas, structural and safety assessment of existing health facilities, and rebuilding are a few of those identified needs.



ANMF USA is in regular communication and collaboration with ANMF Nepal and other organizations to identify areas where we can have the highest impact, and we will work in those areas going forward. ANMF USA would like to thank ANMF Nepal, KAHS, CMS, HFN, HAPSA, ASK foundation, Nepal Government, and everyone working on the ground and remotely for this relief and rebuilding efforts. ANMF would like to thank our donors who allowed us to carry on these relief works.

I am a practicing Reconstructive Plastic surgeon. My practice focuses on correcting congenital deformities such as cleft lip and palate. In 1984, I made my first trip to Nepal to hike with a group of Americans to Lo Boche in the Solu Khumbu area. During return trips in 1985 and

1986, I met Nepali physicians in Kathmandu who encouraged me to volunteer my services to treat the children of Nepal.

From 1987 to 2001, I made multiple trips to train Nepali surgeons and assist them with the Cleft Palate Programs now at TUTH and Kirtipur Hospitals. These programs continue to provide coordinated cleft care to the children of Nepal. With our various training sessions and educational courses, we established and grew cleft lip and palate surgery programs in various parts of Nepal. ***

In the Spring of 1997, I received a call from Arjun Karki, then a resident in the Critical Care Program at Brown University in Rhode Island. He encouraged me to attend the upcoming ANA meeting in July at Brandeis University. ANMF came into being during that meeting. I currently serve as a member of the Collaboration Committee. Previously, I have facilitated projects supported by ANMF, including:



□ A Speech Therapy Program created to train children following cleft palate surgery

□ Funding for the Skin Bank Program for care of patients post-burn.

Both of these projects were directed by my colleague, Shankar Rai.

During my time on the Board, ANMF has grown dramatically. There have been multiple occasions when the efforts of ANMF have significantly impacted the ability to deliver healthcare in many areas of Nepal. These include but are not limited to, funding: - Construction of health care centers that were then turned over to the government to staff and maintain - Delivery of oxygen plants to hospitals to provide for their patients with pulmonary problems

-Creation of the SIM Lab at Bir Hospital

Project Highlight: Burn Care and ICU Management in Nepal

Burn injuries are a significant public health problem, which can lead to high morbidity and mortality. These injuries can arise from direct contact with surfaces, fire, hot liquids, chemicals, gasses, electricity, or radiation, which cause tissue damage inside or outside the body. Over 90% of burns are avoidable, and 95% of burn deaths occur in low- and middle-income countries and are preventable. The World Health Organization identifies burn injuries as the fourth most prevalent traumatic injury, accounting for 180,000 deaths annually, and its incidence is high in low- and middle-income countries. The treatment of Burns is not well organized. The number of beds available for admitting patients with burn injuries is minimal. There are few plastic surgeons in and outside the country. The outcome of burn care in Nepal is inferior limited by factors like late arrival of burn patients in the treatment center, poor economic conditions of patients and costly burn treatment and, lack of proper physical infrastructure for taking care of acute burn patients, and lack of trained human resources plays an equal role.



The Cleft and Burn Center of Kantipur Hospital, run by Public Health Concern Trust- Nepal (check-NEPAL), is the de facto center for the acute care of these patients. It is the only center with a dedicated Burn ICU with seven beds and two dedicated operating rooms for burn patients. Knowing the ground reality of Burn Care in Nepal-America Nepal Medical

Foundation (ANMF) has responded to the proposal sent by Kantipur Burn Center on April 20, 2023. The annual grand meeting 2023 of ANMF unanimously agreed to a donation of USD 100,000 to uplift the ICU infrastructure and care at the Burn Center. ANMF commends the services provided by local experts at Burn Center and congratulates dedications from Dr. Kiran Nakarmi and Dr. Shankar Rai.
