Agenda Item 1 Blood Management - Project ID: 19LBF001

Discussion

PC committee agrees that the idea itself is very noble and genuine. This does align with the ANMF mission. The fund is being asked for fixed startup cost (25,000 USD) and operating cost for the first year (26,268 USD). Concerns were raised about the sustainability and monitoring of the program but PC feels they were satisfactorily answered by Shristi Piya from

Hamro LifeBank. Dr. Bhupendra from Nepal raised concerned whether this project has been approved by Blood Bureau or not.

PC Recommendation

No firm recommendation yet. Provided they have approval from all necessary authorities including Blood Bureau ANMF might consider granting 18k USD as seed money Follow Up Dixa will follow up on this issue and Dr. Bhupendra will confirm this approval from Nepal side.

Agenda Item 2 Ventilatory Rehabilitation Center - Project ID: 19NCCDF001

Discussion

134,000 USD asked to start the ventilator rehab center pretty much from scratch and to maintain and sustain the center including the rental for place, equipment and salary for workforce. Their revenue from 10 patients is not going to sustain the center. Noble plan but out of scope for ANMF. PC Recommendation **Disapproved** Follow up NA
