D.Project Updates- Oxygen plants 21ANMF005/21ANMF006/21ANMF007

Paperwork was done for sea transportation. Medioxy has sent funds to Novair but is facing some hurdles in sending dollars from Nepal to France. After receiving the fund, it will start repackaging the plants, and the shipping date will be confirmed. Board will get an update regarding the transportation cost if the amount exceeds USD 30,000. Funds left in ANMF Nepal

may be able to cover nominal expenses if the cost of transportation changes.

E.Policy Updates

A.Project Proposal submission guideline #4 (as listed in the website) will be revised to include "wages" and will read as follows- Proposals for wages, travel, accommodation, and

dining/living costs will not be accepted. Exceptions will be made on a case-by-case basis.

The PC feels that now is not the time to spend more funds on Covid projects. We suggest writing a letter of encouragement to IRHDTC in the hopes of receiving future innovative project proposals.

4) Provide Quality Medical Care to the Poor 22FSB001

Information: Request is for ANMF to financially support one full-time medical doctor for three years to address patient concerns and provide counseling, diagnosis, and treatment. Proposal is for 3 years' wages for a medical doctor.

Earlier, the board discussed in detail about policies regarding the project that proposals for wages will not be accepted. PC denied it for the same concern.

5) Equipment for Sim Lab at Bir Hospital 22ANMF003

Proposed date: 25th March 2022

Grant amount: \$ 99,332.

USA Project Manager: Jiwan Lamichhane

Submitted by: ANMF/Nepal.

Information: ANMF with the partnership of Bir Hospital will be helping to establish a state-of-art Sim lab at Bir Hospital. ANMF will provide funds for the procurement of different equipment needed for the simulation lab at Bir Hospital. Bir hospital is heavily invested in this project. The detailed list of the items submitted is attached as Appendix A. We are awaiting a detailed budget, other funding sources like WHO, EU and some assurance about Simlab sustainability from ANMF/Nepal.

Once more information is obtained web-ballot will be conducted. Likely this will be one of the several projects for fundraiser at the upcoming AGM.

I.21NCCDF002 Scholarships awards critical care nursing training (NCCDF): NCCDF have completed the project. SWC approval on 3/13/22. Fund transferred 3/23/22. The completion report is pending. Bhupesh has asked for photos and videos to include the stories of 10 participants from outside the valley who got trained for 3 months at HAMS hospital. US Managers: Jivan & Shraddha.

II.21MAIT001 "Ensuring health and well-being for the beneficiaries of Maiti Nepal" (Maiti Nepal): Report received on 3/9/22. Over 200 women benefitted and they only used 2300 USD thus far. Over 4600 USD is still to be used. US Manager: Julia

III. 21MMDC002 Oxygen plant (Pharping): USM-Narayan N-need SWC approval n MOU. It is because; they have not developed a clear policy on this topic and are still working on it under the governance of the Federal Government. **No new update**

IV. 21NIRI001 Determinants and burden of non-communicable diseases in adults and respiratory health in children: a longitudinal family cohort study in Nepal (USM Dinesh S) needs MOUs after pending SWC approval. **No new update**

V. Acute Burn Care 21PHCT002. Grant amount: \$35,000 grant. USA Project Manager: Jivan Lamichhane. **No update.**

VI. Community Covid Training 22HAPS002. Grant amount: \$ 10,000 . USA Project Manager: Bikash Bhattarai. **No Update.**

I. Annual General Meeting on 5/21/22. Plans and Preparation (Binod Khadka)

The theme for 26th AGM will be **Envisioning healthier Nepal together!** Besides housekeeping presentations from the organization, we will also be doing fundraising for specific projects and also for the generic goal of Advancing healthcare in Nepal which will be used for different upcoming projects. It will start at 8 pm EST. Santosh, Sandesh, Jivan, and Shreebatsa Dhital will help with IT needs. Chair from different committees will be allocated some time to give a gist of what their respective committee does.

There are 6 new applicants for the board. Vikash Pathak, Swikrity Upadhyay, Navin Kaini, Saroj Kandel, Bikash Bhattarai, Narayan Neupane so far. The new board decides the officer. Binod envisioned making the board as inclusive as possible. It was discussed that the board members be involved in a committee.

The deadline for the application submission will be next week 04/18/2022. Bishnu will work on the press release. Zoom capacity needs to be increased for the event!

J. Executive Director for ANMF

The Extended Executive Committee meeting met on 3/20/22 and recommended that the board consider creating and hiring for the position of executive director for ANMF. See Minutes. Back in October when the idea was floated for the Executive director board was open to it. Preliminary "Roles and Responsibilities" of this position is drafted by Bhupesh and is circulated to the board and is subject to change based on the board's feedback.

Discussions in the board

- 1. Possibility of funding this position from Nepal
- 2. Need homework to figure out a way to pay for the director stationed abroad. Do we have to be listed as INGO in Nepal to make it happen?

- 3. Need to be done as a trial/test rather than a decision.
- 4. Should not impact the low-cost/ high-impact reputation of the organization.
- 5. If we continue to do disaster work, then having someone taking the lead to coordinate with several other relief organizations makes sense.
- 6. Our budget has grown irrespective of the disaster. It means the scope of the work has broadened.
- 7. Need to continue to discuss the Endowment fund for ANMF
- 8. The board might have a consensus to hire for an interim position as a trial for a year with midterm analysis in 6 months and clause of no-cause termination. Few board members have expressed that this might be too short of a time to perceive the impact.
- 9. Need to devise ways to evaluate.

- 11. Need to expand the thinking to include the implications of litigation.
- 12. Bhupesh asked Kalpana, Marvin, and Julia to provide feedback to the board about the pros and cons of this position from the accounting, legal and managerial perspectives via email.
- 13. No motion for votes was called at this meeting for the executive director position.
- **K.** Automation: Quote for fundraising platform and event management (Bhupesh)- Few quotes from different organizations were forwarded to the Board. Members provided feedback that it wouldn't be a good fit for our organizations. Possibility of creating our own database! Binod Dhungana will look into the CRM(Customer Relationship Management) that his company in Nepal uses.
